INFORMATION SHEET

- DATES:** APPROXIMATELY JULY 23 – AUGUST 4, 2010
(DEPENDING ON TRAVEL ARRANGEMENTS)
- TENTATIVE TRAVEL PLANS:** THE GEORGIA-CAROLINA COUNCIL JAMBOREE CONTINGENT WILL LEAVE AUGUSTA ON FRIDAY, JULY 23 AND TRAVEL TO THE WASHINGTON D.C. AREA FOR TOURS AND SITE-SEEING. THE CONTINGENT WILL ARRIVE AT THE JAMBOREE SITE ON MONDAY, JULY 26 AND CAMP UNTIL THE MORNING OF WEDNESDAY, AUGUST 4 AND ARRIVE BACK IN AUGUSTA THAT EVENING. TRAVEL WILL BE BY TOUR BUS.
- ORGANIZATION:** THE JAMBOREE IS OPEN TO ALL WHO ARE QUALIFIED BOY SCOUTS ON A FIRST-COME BASIS. AFTER OUR TROOPS HAVE BEEN FILLED, A STAND-BY LIST OF ALTERNATES WILL BE ESTABLISHED. SCOUTS WILL BE ASSIGNED TO A JAMBOREE TROOP CONSISTING OF 36 SCOUTS AND 4 ADULT LEADERS. YOU WILL BE A MEMBER OF A PATROL WITHIN THE TROOP. THE COUNCIL CONTINGENT WILL CONSIST OF 2 TROOPS.
- TOTAL COST:** ESTIMATED AT THIS TIME TO BE \$1,700 FOR SCOUTS AND LEADERS. TRANSPORTATION COSTS MAY EFFECT THIS FEE.

- FEE INCLUDES:** THE JAMBOREE FEE COVERS ALL TRANSPORTATION, TOURS, ADMISSION FEES, MEALS, LODGING, AND PATROL AND TROOP EQUIPMENT, AS WELL AS INSURANCE. YOUR FEE ALSO COVERS THE TRAINING CAMP BEFORE THE JAMBOREE. THE ONLY ADDITIONAL EXPENSE WILL BE YOUR PERSONAL EQUIPMENT, UNIFORMS, AND SPENDING MONEY.
- REFUND POLICY:** IF YOU SIGN UP FOR THE JAMBOREE AND THEN FIND THAT YOU CANNOT ATTEND, YOU WILL RECEIVE A FULL REFUND FROM THE GEORGIA-CAROLINA COUNCIL ONLY IF THERE IS AN ALTERNATE TO TAKE YOUR PLACE. IN THE EVENT THERE IS NOT AN ALTERNATE, A PARTIAL REFUND WILL BE MADE. THIS INCLUDES THE FEES YOU HAVE PAID TO DATE, LESS ANY EXPENSES RELATED TO CONTRACTUAL AGREEMENTS MADE ON YOUR BEHALF.
